Opportunities for activation exist under the Commercial Activities on Public Land Policy and Activities on Footpaths and Roads Policy. Discussions have been held with Albury Business Connect who are letting their members know of our support of additional outdoor dining spaces/chairs, without the requirement for a DA. Application process is streamlined to enable approval after the business consults with neighbouring businesses to use the additional space. This has been actively promoted by our Economic Development and Education/Compliance team. From a strategic perspective, additional areas within the CBD can also be considered as part of the CBD Masterplan reviews to be undertaken by City Development in 2021/22. In addition, Albury Business Connect is undertaking consultation with businesses regarding a potential Parklet trial in both the Albury and Lavington CBD's, which is being supported by AlburyCity. Investigations are expected to conclude by May 2021.

Consider as part of CBD Masterplans review to be undertaken in 2021/22.

Council is currently working through the implementation of the Albury CBD Bike Loop. Following the completion of this, work will commence on the planning, design and consultation for the Lavington CBD Bike Loop.

Identification of required sites to be led by City Development. Requires completion of strategies such as TW Drainage, Open Space Strategy etc. In total \$2M has been provided for in the draft Four Year Delivery Program for 2023/24 to 2024/25.

Works are commencing on the design of the plan and acquisition of the final parcels of land to facilitate the construction. Environmental assessments are underway with the project being assessed as having a significant impact. Accordingly it has now been referred for consideration at a Federal level, which can be up to a 12 month process. This time will be utilised to continue to bring the design to a construction stage.

Council is currently working with TfNSW to develop an implementation plan for the delivery of the strategy.

Following the Pre-meeting Briefing Session on 15 February, a review of the proposed path construction along the length of Walsh Street, East Albury was completed. A possible alignment has been identified which will provide a concrete path along the entire length of Walsh Street, from Schubach to East Streets. While our preferred width of a 1.5m path may not be possible for the entire length of Walsh Street, due to narrow nature strips and a number of constraints within the nature strip, the plan is to fit the path as best as possible to provide safe pedestrian access along the street. Further to this, funds have been identified in the current year budget, due to savings realised in other footpath construction projects, which could allow for the construction of the 850 lineal metre (part of) the path this year. These works will connect to another path construction project along Jamieson Street which has just been awarded and will be constructed during 2020/21. A request for quotation is currently being prepared to inform the potential allocation of this project across the current and Draft 2021/22 Operational Plan and subject to further community consultation.

This investigation will include the analysis of potential sites and the associated land acquisitions that may be required. The review of the Murray River Experience Masterplan and Albury CBD Masterplans will give consideration to future uses for the existing site. Any future utilisation of this land will need to be negotiated with Crown Lands. A budget item has been included in the 2021/22 draft budget to undertake a feasibility study for a future site.

The naturalisation of the creek is being considered as part of the review of the Murray River Experience Master Plan, which is currently considering opprtunities to naturalise the Creek behind the Albury Swim Centre. This is further supported by the draft Fredericks Park Masterplan, which also identifies the opportunity to investigate the feasibility of re-naturalising parts of Bungambrawatha Creek.

To facilitiate implementation of the Masterplan, there has been \$50K identified in 2021/22 to complete detailed design, as well as an additional \$550K identified in 2022/23 for construction. The Masterplan has incorporated the request to re-align the path through Memorial Bowl to align better with Memorial Pathway. A separate body of work is currently being undertaken to remove saplings and clear the sight visibility along Memorial Pathway, as well as preliminary investigation of pathway lighting.

This is NSW specific. Victoria has a different approach and state funding opportunities. We will certainly seek to consult with Wodonga Council, and other key stakeholders, when we commence engagement for the development of the next Crime Prevention Plan scheduled for 2021/22. The Graffiti Management Plan is currently being developed and consultation with Wodonga regarding combined initiatives will continue. A functional review of the Communities Team is currently underway to determine current and future resourcing required to deliver on existing and proposed community safety and crime prevention plans and strategies.
